Water Matters Forum in Tifton

-Water is our life blood; without water, we perish-

A group of South Georgia concerned citizens joined together to host an all-day forum on all aspects of water issues: availability of quality water, conservation, legislative concerns and citizen advocacy opportunities.

The event took place on Saturday, August 21st in Tifton at the University of Georgia's National Environmentally Sound Production Agriculture Laboratory and featured a variety of experts on a diversity of water-related topics.

The overall goal of the forum was to bring attention to water as a precious resource, seeking to educate, inform, and energize those who attended the event.

The event was well-attended demonstrating the interest of "downstream" communities in the future of South Georgia's water rights compared with state-wide water policy. The *Water Matters* steering committee will continue organizing similar events and empowering citizens about 'water matters'! FRk currently serves as the fiscal sponsor of this group.

A Fleet of Canoes and Kayaks for Flint River Experiences

The FRk extends its gratitude to Brent Troncalli of Outside World outfitters in Dawsonville for assisting us in the purchase of a fleet of canoes, kayaks, a hauling trailer, dry bags, paddles and personal floatation devices.

These boats will be utilized as part of the FRk's Outreach and Education efforts. By offering guided experiences on the river and her tributaries, the FRk works to encourage river stewardship, understanding of the river's ecology and promote the Flint as one of Georgia's most accessible riverways.

FRk has already guided two groups down the river. The first trip included members of the 2010 IGEL who paddled through downtown Albany. The second trip was a group of eight middle school students participating in the HennyPenny Video/Television Production and Training Program. As part of the Southwest Georgia Training program, in association with Jokara-Micheaux Production Studio, this group is creating a documentary about life on the Congo River. Footage from their Flint River trip from Newton to Camilla will be incorporated into the documentary to highlight communities' relationships with river resources.

Georgia Adopt-A-Stream Monitors Needed

Georgia Adopt-A-Stream (AAS) is a volunteer based waterway monitoring and protection program housed in the NonPoint Source Program in the Water Protection Branch of the Georgia Environmental Protection Division. Manuals, training, and technical support are provided through Georgia EPD and the more than 50 established Community/ Watershed Adopt-A-Stream organizers.

The goals of Georgia Adopt-A-Stream are to (1) increase public awareness of the State's nonpoint source pollution and water quality issues, (2) provide citizens with the tools and training to evaluate and protect their local waterways, (3) encourage partnerships

between citizens and their local government, and (4) collect quality baseline water quality data.

To accomplish these goals, Georgia Adopt-A-Stream encourages individuals and communities to monitor and/or improve sections of streams, wetlands, lakes or estuaries. To better understand the health of our waterways Georgia Adopt-A-Stream offers training and certifications in chemical, biological (macroinvertebrates), bacterial, visual, and amphibian monitoring.

Flint Riverkeeper and Georgia Adopt-A-Stream are coordinating interested citizens in our watershed to be trained to monitor the Flint and her tributaries for pollution indicators. Partners within the Flint Basin include the Flint Riverquarium, local coordinators such as Dr. William Tietjen and Melissa Martin, and GA AAS State coordinators.

The FRK's goal is to host training events and certify monitors in every portion of the Flint River watershed within the next two years, continuing strong initiatives that are presently occurring.
